

## **Grant Application: SIAB Golf Outing**

The Society of Italian American Businessman (SIAB) will hold its Eighth Annual Charity Golf Outing on Monday June 17, 2024 at the Maryland Golf and Country Club, Bel Air Maryland.

SIAB is seeking 501(c)(3) nonprofit charity partners to help market, promote and sponsor the event for up to a two-year term. In return for the partnership, SIAB will share a percentage of the available grant monies related to the golf outing with each respective partner. Funding allocation will be performance based.

The level of support required for the partnership funding is as follows:

- Commit resources for up to (2) years (consecutive golf tournaments).
- At least (1) representative attend at least four (4) monthly planning meetings (Bel Air weekday evenings) leading up to the golf tournament.
- Work with our Silent Auction committee to coordinate the event and leverage resources to procure and prepare items for the auction.
- Help solicit potential sponsors and participants.
- Provide at least 6 volunteers for the entire day of the golf tournament inclusive of pre & post activities. Assignments TBD ranging from 8am to 6pm.

As per SIAB's By Laws the grant recipients must be based in Harford County or provide services in Harford County.
